Passport & Visas & Formalities

You are responsible for a valid passport, visa, medical and travel insurance to cover your program.

Course Terms & Conditions

- -- No course is less than 1.5 lessons once.
- --An additional 10 RMB per lesson will be added when the lessons are less than 2 lessons once.
- --An additional 10 RMB per lesson will be added when lessons are gave outside of regular working hours.
- --Transportation fee will be added when lessons are gave outside of the center.
- -- Expiry Date: Student must finish a course within a certain number of weeks after their start date. 50 lesson: 20 weeks; 100 lessons: 30 weeks; 150 lessons: 40 weeks; 200+ lessons: 60 weeks. Students that fail to complete their courses within the expiry date will be deemed to waive their remaining lessons and no lesson transfer or refund will be available.

Course Cancellation, Changes & Refund Policy
